Transparency Register as a KPMG Law Service

Objectives & Context

The Transparency Register was created with the aim of preventing money laundering and exposing terrorist funding; registers of beneficial owners ("UBO") have been set up in the EU



Germany:

All legal entities under civil law (including associations and foundations), listed partnerships, trusts and comparable legal forms, are obligated to register and to report changes

European Union (EU):

Different legal and organizational approaches give rise to considerable reporting and monitoring efforts

- The (fictitious) beneficial owner is already definded or will be determined with the support of KPMG Law

Complete maintenance of the transparency register by
KPMG Law

- Checking the notifications to the commercial register and for changes to the fictitious beneficial owners and their personal data using current extracts from the electronic commercial register, in each case every two months)
- Obtaining confirmation from the respective beneficial owners at the end of March, June, September and December (end of quarter) of each year that the personal data on the beneficial owners already reported to the Transparency Register is up to date
- If there are changes to the aforementioned data, obtaining the client's confirmation of the data to be reported and then entering the changes in the KPMG Law Transparency Register tool and reporting them to the Transparency Register
